Describe how funds will be utilized: Yarn will be knit into re-imagined garments responding to the knitting histories of Guernsey, the Shetland Islands and the Cowichan tribes of British Columbia, histories in danger of dying out if sweaters are no longer needed in these traditionally cold areas. Three items will complete a series of 5, two of which are complete. Torso display forms will be used to display each garment which will then be incorporated into a display with maps and didactic tools pointing to the connection between material culture and climate. This is scheduled for completion for installation in the Lawton Gallery Faculty Show in late January 2011. Images of the existing garments can be seen on my blog, sharpandpointedobjects.blogspot.com. (They're knitted wool bikinis; Aran Isles and Norwegian traditions are represented.)

Narrative:

My project attempts to answer the question of what will happen should global warming have an adverse effect on certain cultural traditions of knitting. Most of the oldest and most respected knitting traditions come quite logically from cold, wet places like the Aran Islands, the Shetland Islands, Guernsey, Norway, and British Columbia. In fact, tourism to the Aran Islands is directly dependent upon the Aran "Fisherman's Knit" sweater, the classic off-white textured traditional pullover worn by fishermen for centuries, distinguished by distinct knit-in patterns of bobbles, cables and basket-stitches. In contemplating traditional knitting, I began to wonder what would happen if these places became warm; through climate change would we eventually lose these knitting traditions, or would they evolve? My answers were somewhat humorous:





My intention is to continue this series. I have planned the Guernsey (or Gansey) suit and the Cowichan (from the NW Coast Salish traditions, adapted from British settlers to the Cowichan Valley near Vancouver, BC.) A Fair Isle (or Shetland) suit is also in early stages of planning. I would like to create an installation of the finished suits, with didactic materials including maps, information on daily temperatures in each location, and imagery to support my thesis that the natural outcome would be an evolution of the knitting materials and styles to my end. I am committed to the UWGB Faculty Show at the end of January 2011 at which I hope to debut the installation. My budget outlines the costs related to the project including appropriate (traditional) wool yarns for 3 additional suits, display forms for the suits, and maps. Photocopies and mounting materials are not included in the budget. Once the installation is mounted at the Lawton, it can be documented, and (with luck) will be presented in a variety of other kinds of exhibition spaces down the road. This project combines my interest and research in both the areas of knitting and fashion history, is relevant in that it addresses the effect of climate on material culture, and is also appropriate to my body of art work to date. As such, it is an interdisciplinary project worthy of institutional support.
