 - v. Need team backpacks for their team supplies
 - 1. Currently using walmart brand backpacks that are breaking and there are not enough backpacks
 - 2. Started process of getting team apparel designed with Josh Moon
 - 3. Total cost \$936 for 26 backpacks
 - 4. Will be green and say GB dance
 - vi. Team Tops
 - 1. Previously, dancers paid for their own tops
 - 2. This year there are not a lot of tops for the team and they want to purchase tops to keep
 - 3. Want to take burden off team because dance is very expensive
 - 4. Total \$1800 for 50 of them
 - vii. Team winter hats
 - 1. Want for parade and travelling
 - 2. Total of \$234 for 26
 - viii. They currently do not have enough of anything for the whole team
 - ix. Currently have fundraised \$10,281 for their black dresses and still owe \$799
 - x. Discussion
 - 1. Riley: why is your agency amount so large?
 - 2. Rep: I could not tell you why because I have not been in charge of it until now. All the money we have right now is from fundraising and donations
 - 3. Nathan: are you asking for an exception for the fundraiser allocation?
 - 4. Rep: yes, we would pay you back later after we fundraised the money
 - 5. Stephanie: you can take this out of your agency if you wanted because you have enough money in your agency
- b. Travel Request
- i. The team has started competing and last year they went to 2 competitions and they average cost is \$17 per dancer
 - ii. This year they plan to go to 4 competitions
 - iii. They can market their team to different schools
 - iv. First one is Ashwaubenon Dance Classic on December 3rd
 - 1. Lets high schools see their team and recruit dancers
 - 2. They compete as well
 - 3. Total cost for competitions is \$1,156
 - v. Oshkosh State Dance Competition
 - vi. Carroll University
 - vii. UW Milwaukee
 - viii. Take their own vehicles to competitions
 - 1. 6 vehicles
