 - 1. JD: What would the timeline look like to implement the bill of rights?
 - a. This is the last senate meeting of the semester. I am planning on the first meeting of the second semester to have the second reading and then would be voted on it then. Then depending on how the senate votes on it would determine what happens next.
 - 2. Sarah: How are we getting this out to students?
 - a. I think handing them out would be a waste of paper since a lot of students would just throw it away. Making it available on the University Website, social media. Posters are an option with a link to the document somewhere on the poster.
 - 3. Reese: Number 11, I can't tell if it is right or not. (#11 The right to have personal information be protected)
 - a. I personally could go either way with wording. Does anyone have any preferences?
 - 4. Mark: With #10, how does it work for the online student population? (#10

 The right to mental healthcare vis-à-vis accessible on-campus counselors and mental health experts,)
 - a. Needs to be adjusted



- Mark: Add something about adding access to mental health counseling.
- c. I'll have it changed up for the second reading.
- 5. JD: Do we need to make formal amendments to this right now?
 - a. Mark: That would be the best way to do it. We could do the amendments now or at the second reading.

 - I can reword that. I will talk to Jared and get familiarized with the process so I can clarify it more.
- 9. Sarah: The best way we should go about this, is not making any official amendments. We have a lot of time to think about this and go over the amendments next meeting. So I think it would be a good idea to toss around



ideas now.
